Refundable Membership Deposit Agreement

THIS AGREEMENT, effective _____ (date), by and among the prospective member _____ (“Member”) and Club Motorsports, Inc (“CMI”).

CMI has requested a refundable deposit be made by the Member to be paid to demonstrate good faith efforts to proceed with the prospective Member’s membership application. The amount of the refundable deposit is ten percent (10%) of the current “during construction” initiation fee price for a membership in CMI’s Motorsports Country Club being constructed in Tamworth, New Hampshire (please see Membership Pricing). All deposited will be held in an escrow account and should be paid by check. The projected opening date of the club is June 1, 2016. This is an estimated date and subject to change based on construction progress.

CMI agrees to provide the Member a copy of the Club Motorsports Membership Agreement for the Member’s review. On or before thirty days after receipt of the Membership Agreement, the Member agrees to notify CMI of the acceptance or rejection of said Membership Agreement. Should the Member reject the terms of the Membership Agreement, the entire deposit will be returned to the Member within twenty one (21) days and both CMI and the Member will have no further obligation under this agreement. If CMI fails to open the facility within one year after the projected opening date, the Member may request to have the entire deposit refunded and the deposit will be returned to the Member and both CMI and the Member will have no further obligation under this agreement.
